We, SESP, SUMITOMO ELECTRIC Schrumpf-Produkte GmbH declare that our heat shrink product lines called SUMITUBE™ and IRRAX™SLEEVE and the IRRAX™TUBE PRODUCTS comply with the requirements of the **REACH** directive on chemicals (1907/2006/EC), the **RoHS 2** directive (2011/65/EU, amended by 2015/863/EU) on hazardous substances in electrical and electronic equipment, the **POP** directive (2019/1021/EU, amendment 2023/1608/EU) and the **Stockholm-Convention** on persistent organic pollutants and with the US-Environmental Protection Agency's **TSCA, section 6(h)** (86 FR 880, ban of 5 chemicals).

**REACH:** Registration, evaluation, authorisation and restriction of chemical substances, which entered into force on 1<sup>st</sup> June 2007. The last update of SVHC-candidate list was published on 23<sup>rd</sup> January 2024 (available to the public via ECHA-REACH home page):

Except for the grades named below we do not add any of these currently listed 240 SVHC to the SUMITUBE™ or IRRAX™ products intentionally.

The exceptions are:

SUMITUBE™ grades:

SA2, SA3, SA3CB, SA3E and SA3HT

SUMISEAL™ grades:

**BHT-NY** 

These grades contain 2,2'-METHYLEN-BIS-(4-METHYL-6-TERT.BUTYLPHENOL) or DBMC, CAS No. 119-47-1, EC No. 204-327-1, added to the SVHC list on 17<sup>th</sup> January 2022.

**RoHS 2**: Restriction of the use of certain hazardous substances in electrical and electronic equipment (2011/65/EU and its third amendment 2015/863/EU, which is sometimes mistakenly named "RoHS 3").

SUMITUBE™ and IRRAX™ products do not contain substances listed in the 2015/863/EU, appendix II (list of 10) or the concentration is less than (<) 0.1% w/w.

**TSCA section 6(h), PBT 5**: SUMITUBE™ and IRRAX™ products do not contain substances from the list of 5 PBT chemicals or the concentration is less than (<) 0.1% w/w.

Our SUMITUBE™ and IRRAX™ products also complies with the Directive 2000/53/EC on end-of-life vehicles (ELV) and its amendment 2023/544/EU.
